Services include: property management, accounting, customer service, contracts, finance monitoring, infractions, welcome package, architectural control third party, federal and state tax preparation, annual audit, online services, state and federal HOA policies and procedures, assessment collection, board election process, single point of contact, consistency of rule enforcement, etc. Management fee is \$600 per month (approximate increase of \$55/annual assessment fee per property beginning FY 2016-2017). Initial contract is a one year term followed by a 30-day notice for service cancellation.
- 3. Board Minutes of 1/31/2016 presented by Catherine Dikes and uploaded to Nextdoor.Com.
- 4. Social Committee including Nancy Aspaas, Brandee Dill, and Julie Cunningham (not present)received special recognition for coordinating the neighborhood garage sale. Social committee update provided by Nancy Aspaas and Brandee Dill included reflections of neighborhood garage sale; summer social at Chisholm Trail Park Aquatic Center on July 23rd, 7-9 PM; research of Halloween traffic management control, and distribution of three New Neighbor Welcome Gift Bagswhich include a \$25 Home Depot Gift Card.
